Citron Hygiene's online waste pre-acceptance audit & assessment service



Waste pre-acceptance auditing: legislation affecting management of your waste

As a permitted site for healthcare waste, the Environment Agency require us to ensure that the producers of the waste we collect from carry out an audit of the waste before we can accept it. This is known as 'pre-acceptance audits'. This applies to producers of healthcare and related waste. More detail is provided in the Environment Agency briefing note 'Clinical waste pre-acceptance producer update – October 2010'.

This is a legal requirement and failure to carry out audits is a breach of Duty of Care under Section 34 of the Environmental Protection Act 1990 and may result in disposal sites being unable to accept your waste and the Environment Agency could take enforcement action against you.

What is a waste pre-acceptance audit?

A pre-acceptance audit details the process of producing the waste; individual constituents of the waste stream and the hazards associated with the waste. The minimum information your audit must include is provide in Environment Agency guidance note EPR 5.07 pages 25 – 29, which can be downloaded from the Citron Hygiene website.

Providing this information enables us to decide whether your waste can be safely disposed of and will help you to meet your Duty of Care obligations.

Who needs to undertake an audit:

Waste Producer:	Audit Timescale:
Large producers (over 5 tonnes per annum)	Annually
Veterinary practices,	Every 2 years
Dental practices,	Every 2 years
Research laboratories that produce clinical waste,	Every 2 years
General practices and health centres,	Every 5 years
Community pharmacies,	Every 5 years
Care Homes that provide medical or nursing care,	Every 5 years
Any other healthcare premises not listed above e.g. ambulance stations, physiotherapy, optometry, hydrotherapy, medical massage, occupational therapy, speech therapy, chiropody, homeopathy, chiropractic, acupuncture etc.	Every 5 years

How can I carry out a waste pre-acceptance audit?

As the waste producer, you will need to prepare the audit for your premises.

- You may undertake the audit and collect the data yourself, however you need to:
 - ensure that you understand what is required before doing so and that it will be
 - sufficient to enable a decision to be made whether waste can be accepted at the disposal site in accordance with its environmental permit, see 'what is a waste pre-acceptance audit' above.
- You may employ a third party to collect the data on your behalf, or
- Use the Citron Hygiene E-Audit Tool.

N.B. If you submit your own or a third party audit tool, Citron Hygiene will assess the information and use this to advise you on completion of waste documentation, if your waste is being disposed of appropriately or not and provide additional advice on some aspects of your waste practices if necessary.

Why should I use the Citron Hygiene online audit survey?

We have created the new online tool to enable audits to be carried out as efficiently as possible. The E-Audit Tool provides:

- A secure web based online audit tool that guides you through simple questions to fulfil the audit requirements.

- Guidance on how to complete the audit
- Automatic submission to Citron Hygiene with a copy sent to you electronically
- Future online access so you can easily retrieve past audits for compliance with internal/external inspections.
- Regular reminders when re-auditing is due
- Instant feedback on the correct waste containers needed to collect the various types of waste produced.
- Real time information, no longer having to wait for results.

How do I access the Citron Hygiene online waste pre-acceptance audit survey?
