Instructions for use:

- 1) Always ask, as some someone within the business may know the SIC Code
- 1) On the Page 2, find the general description of the business by the number of the Section or Sub-section. This then refers to the Page(s) where that Section/Subsection will be found
- 2) Under each particular Section/Subsection, there are separate Divisions, each with Groups of types of activities – these are all shown in **black text**. Find the Group of activities most relevant
- 3) Each Group of activities is divided into Classes/Sub-classes – these are all shown in **red text** (or *italics* if in black & white)
- 4) An example for Health and Social Work shown below, showing how the various types of premises are divided into Sub classes depending on the activities
- 5) Only one **red text** entry (or if in black and white in the third column only) most relevant to the business must be selected, which may be a four (e.g. **55.21**) or five (e.g. **55.10/1**) number entry
- 6) Entries in **black text** (or those not in italics) must not be selected, and this will mean that the SIC code will not be recognised
